
Cline as “Attorneys for Appellee and Cross-Appellant Elaine Jenkins.” In fact, that Appellee Brief was filed by Russell A. Cline on behalf of all defendants, except Alan Jenkins.¹ This includes Elaine Jenkins and her children Jennifer Elaine Jenkins, Joseph William Jenkins, the estate of Rose Marie Jenkins, Charles Isreal Jenkins, Stanley Wallace Jenkins, Samuel Lorin Jenkins, Rebecca Rachel Jenkins, and Jesse Taylor Jenkins.

Russell Cline appeared in the trial court on behalf of all defendants, except Alan Jenkins. See, e.g., R. 147. The Cross-Appeal was filed on behalf of “all defendants, except Alan Jenkins.” See Notice of Cross-Appeal, R. 337. Furthermore, in the Appellee Brief, the term “Elaine Jenkins” was defined as “Elaine Jenkins and her children.” See Appellee Brief, paragraph 37, page 8 (“Elaine Jenkins and her children (sometimes collectively referred to as ‘Elaine Jenkins’)”...)

Accordingly, the cover of the Appellee Brief is hereby corrected to reflect that it was filed by Russell A. Cline as “Attorney for Elaine Jenkins, Jennifer Elaine Jenkins, Joseph William Jenkins, the estate of Rose Marie Jenkins, Charles Isreal Jenkins, Stanley Wallace Jenkins, Samuel Lorin Jenkins, Rebecca Rachel Jenkins, and Jesse Taylor Jenkins.” The Appellee Brief was, in fact, filed on behalf of Elaine Jenkins and her children.

¹Alan Jenkins was never served and never appeared in the above-captioned action. Accordingly, no appeal was filed against Alan Jenkins.
