

ARGUMENT

I. THE TRIAL COURT ERRED IN NOT FINDING THAT THE ROAD WAS DEDICATED TO THE PUBLIC THROUGH TO ITS LOGICAL TERMINUS

It is the position of Jacob Christensen that the trial court erred in not finding that the Road was dedicated to the public from at least point K on Trial Exhibit 117 up to Boyer Lake and Joyce Lake. As a result of the trial court's failure to find this portion of the Road public, Jacob Christensen is unable to access the Blue Lakes as well as certain portions of its property.


Accordingly, Jacob Christensen hereby joins in the arguments of Boyer supporting such finding of public dedication.

CONCLUSION

Because the trial court erred in not extending the public Road to its logical – as well as legally and factually supported - conclusion the trial court's determination that the public portions of the Road do not extend through the Boyer property should be reversed.


